### MillsOnline Updates

Among recent updates to the MillsOnline database of pulp and paper mills are the following:

- The mill at Park Falls, WI, formerly owned by SMART Papers, LLC has changed hands. It is now owned by Flambeau River Papers, LLC.
- The mill in Versailles, CT, has been sold to Cascades, Inc. and will operate under the name "Cascades Boxboard Group-Connecticut, LLC, Versailles Mill." The mill was previously owned by Caraustar Industries, Inc.
- The former SMART Papers, LLC mill in Hamilton, OH has been sold to Plainfield Asset Management.

## CPBIS to Have Strong Presence at Upcoming TAPPI/PIMA Meeting

CPBIS will contribute three sessions to the program for the 2007 TAPPI Papermakers & PIMA International Leadership Conference, to be held in Jacksonville, FL at the Hyatt Regency Jacksonville Waterfront, March 11-15, 2007. The first of these, "Trends in Digital Printing," will examine, from both academic and industrial viewpoints: the relative importance of the different properties of digital papers; factors underlying purchase decisions; gaps in currently-available digital grades; and the effect of competition on turnover rates in digital printing as compared to traditional printing. In the second CPBIS session. "Innovation: The Key to Competitiveness," industry experts will outline the need for innovation and potential pathways to achieving it. The third session, "Trends and Issues in Emerging Markets," will examine emerging markets, such as those in China, India and Russia, from industry and financial viewpoints.
